# YOUR RIGHTS AND YOUR PERSONAL DATA

Subject to an exemption under GDPR, you have the following rights with respect to your personal data

The right to request a copy of your personal data which Essential |Homecare Services holds about you.

The right to request that Essential Homecare Services corrects any personal information if it is found to be inaccurate or out of date.

The right of erasure of your personal data where it is no longer necessary for Essential Homecare Services to retain such data.

The right to withdraw consent to the processing of data at any time

The right to request Essential Homecare Services to transmit your data to another organisation where applicable.

Where there is a dispute in relation to the accuracy or proce4ssing of your personal data, you have the right to request a restriction is placed on further

processing.

The right to object to the processing of personal data where applicable. However, as the 'Authority' will mainly be processing data based on the performance of a statutory duty in the public interest, there are limits to this right. The right to lodge a complaint with the Information Commissioners Office.
